I. Immigrant integration at a crossroads today

- Early 2000s: rise of traditional immigrant integration policies in mainland Europe
- Since 2010: from targeted policies and siloed departments to a more "mainstreamed" approach
- Changing socio-political context



II. Mainstreaming: why – what – how

- Changing demographics: superdiversity
- Austerity and budget cuts
- Sense of failed (one-size-fits-all) integration measures
- Avoiding stigmatisation and prioritisation



II. Mainstreaming: why – what – how

- Mainstreaming through discourse, governance and concrete policies
- Sharing immigrant integration priorities and responsibilities
- Beyond remedial or add-on policies: structurally reforming or adapting mainstream policies for a diverse population



III. Ways forward: opportunities and challenges

Opportunities

- Whole-of-government approach
- Addressing needs, not background
- Avoiding stigmatisation or prioritisation
- Using funds effectively

Challenges

- Mainstreaming is not a goal in itself, but a method
- Mainstreamed approach is not absolute: balance between targeted and generic
- Assuming (final) responsibility and ownership
