





Invited Academic Seminar: Innovation in city-level reception of asylum seekers and refugees: Neighbourhood connections, wellbeing and skills 28th June 2018 9.30-14.30, Het Huis, Boorstraat 107, Utrecht

Cities are recognised as sites in which reception and integration of asylum-seekers and refugees occur, and as spaces where innovative strategies can be developed. This academic seminar comes at the mid-point of one such innovation, the Utrecht Refugee Launchpad (U-RLP), an initiative led by Utrecht City Council in collaboration with a range of partners. The intervention aims to develop a more dynamic, socially inclusive and 'future-proof integration process' (whether in the Netherlands or elsewhere) for asylum seekers and refugees. Its novel approach bucks the trend of dominant approaches to reception, by embedding the initiative in the local neighbourhood through co-housing and co-learning, offering skills training and network- building opportunities to neighbourhood participants as well as centre inhabitants. These, and other supportive strategies, are expected to enhance participants' wellbeing, allowing for personal growth and the experience of more future-oriented narratives and temporalities than offered by dominant approaches to asylum seeker and refugee reception.

The event brings together members of the U-RLP research team and its international advisory board with local academics. Its goals are to reflect on early findings from the project evaluation and gain knowledge and insight from research on similar interventions in other European and Dutch cities. Respondent-led debates will explore topics including:

- Neighbourhood connection: How can cities address anti-immigrant sentiment, local hostility and tensions against asylum-seekers within new initiatives? What is the role of municipalities in communication with local residents? What opportunities and challenges do novel co-living and co-learning strategies offer for reception, longer-term integration (here or elsewhere) and participants' wellbeing? What sorts of strategies for generating social connection work, and on what scale? What spaces and sites work best for encouraging interaction, mutual recognition and respect?
- Skills and wellbeing: What opportunities and challenges are presented by offering skills training (e.g. language and entrepreneurship) as part of the reception experience? How best can mentoring and integration in local business networks work to enhance the future labour market prospects of refugees? How do these different approaches work alongside psychological support interventions to facilitate opportunities for agency and narrative (re)construction? What are the pros and cons of these interventions for current wellbeing and future prospects of asylum seekers and refugees?

In considering these questions, we seek to learn from knowledge and research on similar initiatives at the city level, as well as from academic research addressing broader normative questions on the role of cities in migrant reception and integration. We will also consider some of the methodological challenges and innovations that are required of empirical research and evaluation of such initiatives, to develop the contributions of research in this field.
